#### TERMS AND CONDITIONS:-

1. The offer of appointment is contract basis for a minimum period of one year in the first instance.
2. The contract appointee will be paid fixed emoluments of equal to 60% of first cell of level-16 of the Pay Matrix (₹ 48,700-1,54,300) i.e. @ ₹ 29220/- per month. The contract appointee will be entitled for 3% annual increase in the fixed contractual emoluments for further extended years and no other allied benefits such as senior/ selection scales and NPA etc. shall be given.
3. The service of the appointee will be purely on contract basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
4. The private practice of any kind, whatsoever, is strictly prohibited.
5. The contractual Ayurvedic Medical Officers will be entitled for one day casual leave after putting one month's service, 10 days medical leave and 05 days special leave in a calendar year. This leave can be accumulated upto one year. No leave of any other kind except above is admissible to the contractual appointee. He/She shall not be entitled for Medical Re-imburement and LTC etc. Apart from above a female contract appointee shall also be entitled for maternity leave as per rules.

Provided that the unavailed Casual Leave and Medical Leave can be accumulated upto the calender year and will not be carried forwarded for the next calendar year.



6. Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. The contract Appointee shall not be entitled for contractual amount for the period of absence from duty.
7. The Contract Appointee will not be entitled for his transfer before completion of three years tenure at one place of posting. This transfer will however, will be on need based, wherever required on administrative grounds.
8. Selected candidate will have to submit a certificate of his/her fitness from Medical Board, DDU Hospital, Shimla-1. Women candidate who are pregnant beyond 12 weeks will be deemed temporarily unfit till the confinement is over. The women candidate will be re-examined for the fitness.
9. The contract appointee will be entitled for TA/DA, if required, to go on tour in connection with his/her official duties at the same rate as applicable to regular Ayurvedic Medical Officer at the Minimum of Pay Scale.
10. The candidate engaged on contract basis under these Rules shall have no right to claim for regularization/permanent absorption as Ayurvedic Medical Officer in the Department at any stage.
11. The selected candidate shall have to submit a declaration to the effect that he /she has not/shall not have more than one living spouse/shall not marry a person who has a living spouse.
12. The selected candidate shall have to produce the character certificate from 1<sup>st</sup> Class Magistrate and on oath of allegiance/faithfulness to the Constitution of India or making sole affirmation to that effect while joining the service.
13. He/She shall submit attested copies of the degree(s) and testimonial(s) to the Director, AYUSH and got verified/checked up before submitting joining report to the concerned District Ayurvedic Officer.
14. If the degree/any related document(s) of any selected candidate(s) is/are found fake at the time, his services shall automatically stand terminated and he/she shall be liable for penal action under the law.
15. The selected candidates have to sign an agreement in duplicate (**one copy of Stamp paper of ₹ 10/- & second copy on judicial paper**) as per specimen of Agreement Annexed as **Annexure-"A"** of his /her contract appointment with the Employer i.e. Secretary (Ayush) to the Govt. of H.P. before joining the service.
16. The appointment shall be subject to the verification of Character, Antecedents Medical fitness from the State Medical Board, DDU Zonal Hospital, Shimla-1. In case the adverse

verification of antecedents is received, the contract is liable to be terminated from the date he/she joins the service.

Provisions of service rules like FRSR, Leave Rules, GPF Rules, Provision of Rules & Conduct-rules etc. as are applicable in case of regular employees will not be applicable in case of contract employees.

If the above terms and conditions are acceptable to him/her, he/she should report for duty at his/her place of posting **on or before 26.10.2022** after submitting Medical Fitness Certificate to the concerned District Ayurvedic Officer and after signing the agreement as **per terms and conditions at Sr. No.-15 above**, failing which the offer of appointment shall stand automatically cancelled. The above mentioned Ayurvedic Medical Officer are directed to join duties at their place of posting and send joining report to this department through proper channel. No extension in joining time will be allowed under any circumstances.

AGREEMENT

Whereas, the SECOND PARTY has engaged the aforesaid FIRST  
PARTY and the FIRST PARTY has agreed to serve as Ayurvedic Medical Officer on  
contract basis on the following terms & conditions.

1. That the FIRST PARTY shall remain in the service of the SECOND PARTY as  
Ayurvedic Medical Officer for a period of one year commencing on day of  
\_\_\_\_\_ and ending on the day of \_\_\_\_\_. It is  
specially mentioned and agreed upon by both the parties that the contract of  
the FIRST PARTY with SECOND PARTY shall ipso-facto stand terminated on the  
last working day i.e. \_\_\_\_\_ and information notice shall not  
be necessary.

Provided that for extension/renewal of contract period the  
HOD shall issue a certificate that the service and conduct of the contract  
appointee is satisfactory during the year and only then his period of contract is  
to be renewed extended.

2. The contractual amount of the FIRST PARTY will be **Rs 29220/-** per month.
3. The service of FIRST PARTY will be purely on contractual basis. The  
appointment is liable to be terminated in case the performance/conduct of the  
contract appointee is not found good or if a regular incumbent is  
appointed/posted against the vacancy for which the first party was engaged on  
contract.
4. Contractual Appointee will be entitled for one day casual leave after putting in  
one month service. However, the contract employee will also be entitled for 180  
days Maternity Leave, 10 day's Medical leave and 5 days special Leave. He/She  
shall not entitled for medical re-imburement and LTC etc. No leave of any  
other kind except above is admissible to the contract appointee.

Provided that the un-availed Casual Leave and Medical  
Leave can be accumulated upto the Calendar Year and will not be carried  
forwarded for the next Calendar Year.

5. Unauthorized absence from the duty without the approval of the controlling  
Officer shall automatically lead to the termination of the contract. A contractual  
employee will not be entitled for contractual amount for the period of absence  
from duty.

6. An official appointed on contract basis who have completed three years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.
7. Selected candidate will have to submit a certificate of his/her fitness from a Government/Registered Medical Practitioner. In case of women candidates pregnant beyond twelve weeks will render her temporarily unfit till the confinement is over. The women candidate should be re-examined for fitness an authorized Medical Officer/ Practitioner.
8. Contract appointee shall be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counter-part official at the minimum of pay scale.
9. The Employee Group Insurance Scheme as well as EPF/GPF will not be applicable to contractual appointee (s).
