"OFFICE ORDER"

On the recommendation of Screening/Selection Committee constituted for the selection of Ayurvedic Pharmacy Officer under Handicapped quota, appointment is hereby offered to the post of Ayurvedic Pharmacy Officer on contract basis in the Ayush Vibhag, Himachal Pradesh in the pay scale (PR) of Rs. 5910-20200+3000 (Grade Pay) to the following candidate on the following terms and condition:-

Terms & Conditions:-

1. The appointment will be on contract basis initially for one year, which may be extended on year to year basis.
2. The contract appointees will be paid fixed contractual amount @ Rs.17820/- P.M. (which shall be the 60% of Cell-1 level-8 of revised pay scale under the Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 dated 03.01.2022 will be given.

3. The services of the appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
4. He/She will be entitled for one day's casual leave after putting one month service. In addition, he will also be entitled for 10 days Medical Leave, 05 days special leave. He/She shall not be entitled for Medical Re-imburement and LTC etc. No leave of any other kind except above is admissible to them. Un-availed casual leave and Medical leave can be accumulated up the calendar year and will not be carried forward for the next calendar year.
5. Unauthorized absence from duty without the approval of the controlling officer shall automatically lead to the termination of the contract. He/She shall not be entitled for contractual amount for the period of absence from duty.
6. The candidate will have to submit a certificate of their fitness from the Medical Board/CMO. Women candidates pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidates will be re-examined for medical fitness after six weeks of confinement.
7. The appointment carries with it the liability to serve in any part of Himachal Pradesh under the Ayush Vibhag.
8. He/She will be entitled to TA/DA if required to go on tour in connection with his official duties at the same rate as applicable to regular counterpart officials at the minimum of pay band.
9. Service Rules like FR, SR, Leave Rules, GPF Rules, Pension & Conduct Rules etc. as are applicable in case of regular employees will not be applicable for employees appointed on contract basis.

The appointment will be further subject to the production of the following certificates/declaration:

- i) Attested copies of educational qualification certificates.
 - ii) Disability Certificate
 - iii) Bonafide Himachal Certificate/Handicapped Certificate from the competent authority.
 - iv) Certificate of fitness from Medical Board of the concerned District Hospital.
 - v) Taking an oath of allegiance/faithfulness to the constitution of India or making a solemn affirmation to that effect.
 - vi) Declaration to the effect that candidate shall not have more than one living spouse.
 - vii) Character Certificate.
- No TA/DA will be admissible for joining the post.

If above terms and conditions are acceptable to the above candidates, they should report for duty to the concerned District Ayurvedic Officers, within 10 days from the issue of this order, failing which it will be presumed that they are not interested to join the post and offer shall be deemed cancelled.
