The above appointment will be subject to the following terms and conditions:-

1. This appointment is provisional subject to the final outcome of LPA No.215/2015 of Hon'ble Supreme Court and SLP(C) No. 31435/2016, CWP No. 781/2020 of Hon'ble High Court, H.P., along with other connected matters pending before the Hon'ble Courts.
2. The Ayurvedic Pharmacist in the Department of Ayurveda, Himachal Pradesh, will be engaged on contract basis initially for one year, which may be extended on year to year basis.
3. The contract appointee will be paid fixed contractual amount of Rs. @ 8910/- per month (which shall be equal to minimum of the pay band + Grade Pay). The contract appointee will be entitled for increase in contractual amount of Rs. 267/-(3% of minimum of the pay band + grade pay of the post) for further extended years and no other allied benefits such as seniority/selection scale etc. will be given.
4. The services of contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case his/her performance/conduct is not found satisfactory.
5. The contract appointee, will be entitled for one day's casual leave after putting one month service, 10 days medical leave and 5 days special leave, in a calendar year. A female contract appointee with less than two surviving children may be granted maternity leave for 180 days. A contract employee shall not be entitled to medical re-imburement and LTC etc. No leave of any other kind except above is admissible to the contract appointee: Un-availed casual leave, medical leave and special leave can be accumulated upto the calendar year and will not be carried forward to the next calendar year.
6. Unauthorized absence from duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. Contract Appointee shall not be entitled for contractual amount for the period of absence from duty.
7. A contract appointee after having completed three years tenure at one place of posting will be eligible for transfer on need basis, wherever required on administrative grounds.
8. Selected candidates will have to submit a certificate of their fitness from the Medical Board/CMO. Women candidates pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidate will be re-examined for medical fitness six weeks after date of confinement.
9. Contract appointee will be entitled to TA/DA, if required to go on tour in connection with his/ her official duties, at the same rate as applicable to regular counterpart officials at the minimum of pay scale.
10. Provisions of Service Rules like FR, SR, leave Rules, GPF Rules, Pension Rules etc. will not be applicable in case of contract appointee.
11. Before submitting the joining report, the contract appointee shall sign a contract/ agreement with the appointing authority/authorized representative(s).
12. The candidates engaged on contract basis under these rules shall have no right to claim for regularization/ permanent absorption as Ayurvedic Pharmacist in the department at any stage.
13. He/She will have to give a declaration to the effect that he/she has only one living spouse (if married).
14. He/She will have to produce all the certificates in original at the time of joining.
15. The appointment is provisional and if the verification reveals that the claim for belonging to reserved categories, or educational qualification or technical qualification, as the case may be, is false, the service will be terminated forthwith without assigning any further

- reasons and without prejudice to such further action as may be taken under the provisions of the I.P.C. for production of false certificates.
16. The appointment carries with it the liability to serve any part of Himachal Pradesh under Ayurveda Department.

If, the above terms and conditions are acceptable to the above candidates, they should report for duty to the concerned District Ayurvedic Offices, within 10 days from the issue of this order, failing which it will be presumed that they are not interested to join the post and offer shall be deemed cancelled. No travelling allowance will be allowed to join the contract appointment.
