Short title & Commencement: 1 (1)

- These rules may be called the Himachal Department of Ayurveda, Pradesh Operation Theatre Assistant, Class-III (Non Gazetted), Recruitment & Promotion Rules,
- These rules shall come into force from the (2) date of publication in official Gazette.

- The Himachal Pradesh Department of Indian 2 (1) System of Medicine and Homeopathy, Service (Operation Theatre Class-III Assistant) Recruitment & Promotion Rules, notified vide this Department's Notification No. Health-A (3)-10/87 dated 25-3-1989 are hereby repealed.

Provided further that the employees of all the Public Sector Corporation and Autonomous Bodies who happened to be Government servants before absorption in Public Sector Corporations/Autonomous Bodies at the time of initial constitutions of such Corporations/Autonomous Bodies

shall be allowed age concession in direct recruitment as admissible to Government Servants. This concession will not, however, be admissible to such staff of the Public Sector Corporations/Autonomous Bodies and who are /were finally absorbed in the service of such Corporations/Autonomous after initial constitution of the Public Sector Corporations/Autonomous Bodies. (1) Age limit for direct recruitment will be reckoned on the first day of the year in which the post (s) is /are advertised for inviting applications or notified to the Employment Exchange or as the case may be. (2) Age and experience in the case of direct recruitment, relaxable at the discretion of the Himachal Pradesh Public Service Commission in case the candidate is otherwise well qualified. a) Essential Qualification(s): Minimum educational and (i)10+2 with Science (Physics, Chemistry and other qualifications required Biology) from a recognized Board of for direct recruit(s) School Education/University. (ii)Certificate in O.T.A.course of one year's duration from Medical Institute recognized by Himachal Government/Central Government. b) Desirable Qualification(s): Knowledge of customs, manner and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh

Selection for appointment to the post by contract appointment.

Notwithstanding anything contained in these Rules, contract appointments to the post will be made subject to the terms and conditions given below:-

(I) CONCEPT:

(a) Under this policy the Operation Theatre Assistant, in the Department of Ayurveda H.P. will be engaged on contract basis initially for one year, which may be extendable on year to year basis. Provided that for extension/renewal of contract period on year to year basis the concerned HOD shall issue a certificate that the service and conduct of the contract appointee is satisfactory during the year and only then his period of contract is to be renewed/extended.

b) POST FALLS WITHIN THE PURVIEW OF HPSSSB:-

The Director Ayurveda after obtaining the approval of the Government to fill up the vacant posts on contract basis will place the requisition with the concerned recruiting agency i.e. H.P. Subordinate Services Selection Board, Hamirpur.

(c) The selection will be made in accordance with the eligibility conditions prescribed in these R&P Rules.

(II) Contractual Emoluments:-

The Operation Theatre Assistant appointed on contract basis will be paid consolidated fixed contractual amount @ ₹ 8310/- P.M. (which shall be equal to minimum of the pay band+ grade pay). An amount of 7250/-(3%) of minimum of pay band + grade pay of the post) as annual increase in contractual emoluments for the subsequent year(s) will be allowed if contract is extended beyond one year.

(III)APPOINTING/DISCIPLINARY AUTHORITY:-

The Director, Ayurveda, HP will be appointing and disciplinary authority.

(IV) SELECTION PROCESS:-

Selection for appointment to the post in the case of Contract Appointment will be made on the basis of viva-voce test or if consider necessary or expedient by a written test or practical test the standard/syllabus etc. of which will be determined by the concerned recruiting agency i.e. H.P. Subordinate Services selection Board, Hamirpur.

(V) COMMITTEE FOR SELECTION OF CONTRACTUAL APPOINGMENTS:-

As may be constituted by the concerned recruiting agency i.e. H.P. Subordinate Services Selection Board, Hamirpur from time to time.

(VI)AGREEMENT:-

After selection of a candidate, he/she shall sign an agreement as per Annexure-"B" appended to these Rules.

VII) TERMS AND CONDITIONS:-

- (a) The contract appointee will be paid fixed contractual amount @ ₹ 8310/- P.M. (which shall be equal to minimum of the pay band + grade pay). The contract appointee will be entitled for increase in contractual amount @ ₹ 250/-(3% of minimum of pay band + grade pay of the post) for further extended years and no other allied benefits such as senior / selection scale etc. will be given.
- (b) The service of the Contract Appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance / conduct of the contract appointee is not found satisfactory.

(c) Contract Appointee will be entitled for one day casual leave after putting one month service. This leave can be accumulated up to one year. No leave of any other kind is admissible to the contract appointee. He/She shall not be entitled for Medical Re- imbursement and LTC etc. Only maternity leave will be given as per rules.

Unauthorized absence from the duty without the approval of the controlling officer shall automatically lead to the termination of the contract. Contract

Appointee shall not be entitled for contractual amount for the period of absence from duty.

An official appointed on contract basis who have completed five years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.

Selected candidate will have to submit a certificate of his/her fitness from a Registered Medical Government/ Practitioner. Women candidate pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidate will be re- examined for the fitness from an authorized Medical officer/ Practitioner.

(g) Contract appointee will be entitled to TA/DA, if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counterpart officials at the minimum of pay scale.

(h) Provisions of service rule like FR SR, Leave rules, GPF rules, Pension rules and Conduct rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointees. they will be entitled for emoluments etc. as detailed in this column

- 5. Unauthorized absence from duty without the approval of the controlling officer shall automatically lead to the termination of the contract. A contractual Operation Theatre Assistant (Name of the post) will not be entitled for contractual amount for the period of absence from duty.
- 6. An official appointed on contract basis who has completed five years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.
- 7. Selected candidate will have to submit a certificate of his/her fitness from the Government/Registered Medical Practitioner. Women candidates pregnant beyond twelve weeks will stand temporarily unfit till the confinement is over. The women candidate should be re- examined for fitness from an authorized Govt.authorized / Registered Medical Practitioner.
- 8. Contract appointee shall be entitled to TA/DA if required to go on tour in connection with his/her official duty at the same rate as applicable to regular counter part official at the minimum of pay scale.
- 9. The Employees Group Insurance Scheme as well as EPF/GPF will not be applicable to contractual appointee(s).
