NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 to the Constitution of India, the Governor, Himachal Pradesh, in consultation with HP Public Service Commission, is pleased to make the Recruitment and Promotion Rules for the post of Scientific Assistant Class-III(Non-Gazetted) in the Department of Ayurveda, Himachal Pradesh, as per Annexure-'A' attached to this notification, namely:-

Short title & Commencement: 1 (1) These rules may be called the Himachal Pradesh Department of Ayurveda, Scientific Assistant, Class-III (Non-Gazetted) Recruitment & Promotion Rules, 2012.

(2) These rules shall come into force from the date of publication in the official Gazette.

Repeal & Savings: 2 (1) The Himachal Pradesh Department of Indian System of Medicine & Homeopathy, Scientific Assistant (Pharmacy) Class-III (Non Gazetted) Recruitment & Promotion Rules, 2001 notified vide this Department's Notification No.Health(C)Ka(3)-40/84 dated 3-8-2001 are hereby repealed.

(2) Notwithstanding such repeal, any appointment made or anything done or any action taken under the relevant rules so repealed under sub rule (1) supra shall be deemed to have been validly made, done or taken under these rules.

Provided that upper age limit for direct recruits will not be applicable to the candidates already in service of the Government including those who have been appointed on adhoc or on contract basis;

Provided further that if a candidate appointed on adhoc basis or on contract basis had become over-age on the date when he /she was appointed as such he/she shall not be eligible for any relaxation in the prescribed age limit by virtue of his/her such adhoc or contract appointment;

Provided further that the upper age-limit is relaxable for Scheduled Castes/ Scheduled Tribes/Other categories of persons to the extent permissible under the general or special order(s) of the Himachal Pradesh Government.

Provided further that the employees of all the Public Sector Corporations and Autonomous Bodies who happened to be Government servants before absorption in Public Sector Corporations / Autonomous Bodies at the time of initial of such constitutions of such Corporations/ Autonomous Bodies shall be allowed age concession in direct recruitment as admissible to Government servants. This concession will not, however, be admissible to such staff of the Public Sector Corporations/ Autonomous Bodies and who are/ were finally absorbed in the service of such Corporations / Autonomous after initial constitution of the Public Sector Corporations/ Autonomous Bodies.

- (1) Age limit for direct recruitment will be reckoned on the first day of the year in which the post(s) is /are advertised for inviting applications or notified to the Employment Exchange or as the case may be.
- (2) Age and experience in the case of direct recruitment, relaxable at the discretion of Himachal Pradesh Public Service Commission in case the candidate is otherwise well qualified.

	(1) In all cases of promotion, the continuous adhoc service rendered in the feeder post, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these rules for promotion subject to the condition that the adhoc appointment/ promotion in the feeder category had been made after following proper acceptable process of selection in accordance with the provisions R&P Rules.							

Provided that in all cases where a junior person becomes eligible for consideration by virtue of his/her total length of service (including the service rendered on adhoc basis, followed by regular service/appointment) in the feeder post in view of the provision referred to above, all persons senior to him/her in the respective category/post/cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration.

Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least three years or that prescribed in the R&P Rules for the post, whichever is less;

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the preceding proviso, the person(s) junior to him/her shall also be deemed to be ineligible for consideration for such promotion.

EXPLANATION:- The last proviso shall not render the junior incumbent(s) ineligible for consideration for promotion if the senior ineligible person(s) happened to be ex-servicemen recruited under the provisions of Rule-3 of the Demobilized Armed Forces Personnel (Reservation of Vacancies in Himachal State Non-Technical Services) Rules, 1972 and having been given the benefit of seniority there-under or recruited under the provisions of Rule-3 of the Ex-servicemen (Reservation of vacancies in the Himachal Pradesh Technical Services) Rules, 1985 and having been given the benefit of seniority there-under.

(2) Similarly, in all cases of confirmation, continuous adhoc service rendered on the feeder post, if any, prior to the regular appointment against such post shall be taken into account towards the length of service, if the adhoc appointment/promotion had been made after proper selection and in-acordance with the provision of the R&P Rules.

	<p>Provided that inter-se-seniority as a result of confirmation after taking into account, adhoc service rendered as referred to above shall remain unchanged.</p>

14.	Essential requirement for a direct recruitment.	A candidate for appointment to any service or post must be a citizen of India.

15-A	Selection for appointment to the post by contract appointment.	<p>Notwithstanding anything contained in these rules, contract appointments to the post will be made subject to the terms and conditions given below:-</p> <p>I) <u>Concept:</u></p> <p>(a) Under this policy the Scientific Assistant, in the Department of Ayurveda, H.P. will be engaged on contract basis initially for one year, which may be extended on year to year basis.</p>

	<p>Provided that for extension/ renewal of contract period on year to year basis the concerned HOD shall issue a certificate that the service and conduct of the contract appointee is satisfactory during the year and only then his period of contract is to be renewed/ extended.</p> <p>b) <u>Post falls within the purview of HPSSSB :</u> The Director, Ayurveda H.P, after obtaining the approval of the Government to fill up the vacant posts on contract basis will place the requisition with the concerned requitment agency i.e. <u>H.P. Subordinate Services Selection Board, Hamirpur .</u></p> <p>c) The selection will be made in accordance with the eligibility conditions prescribed in these R&P Rules.</p> <p>II) <u>Contractual Emoluments :</u> The Scientific Assistant appointed on contract basis will be paid consolidated fixed contractual amount @ Rs.14,100/- per month (which shall be equal to minimum of the pay band plus grade pay). An amount of Rs.430/-(3% of the minimum of pay band plus grade pay of the post) as annual increase in contractual amoluments for the subsequent year(s) will be allowed if contract is extended beyond one year.</p> <p>III) <u>Appointment/Disciplinary Authority:</u> The Director, Ayurveda H.P. will be appointing and disciplinary authority.</p> <p>IV) <u>Selection Process :</u> Selection for appointment to the post in the case of contract appointment will be made on the basis of viva-voce test, or if considered necessary or expedient by a written test or practical test, the standard /syllabus etc. of which will be determined by the concerned recruitment agency i.e <u>H.P Subordinate Services Selection Board,Hamirpur.</u></p>

V) Committee for selection of Contractual Appointment :-

As may be constituted by the concerned recruiting agency i.e. H.P Subordinate Services Selection Board, Hamirpur from time to time.

VI) Agreement :-

After selection of a candidate, he/she shall sign an agreement as per Annexure-B appended to these Rules.

VII) Terms and Conditions :-

- (a) The contract appointee will be paid fixed contractual amount @ Rs. 14100/- per month (which shall be equal to minimum of the pay band plus grade pay). The contract appointee will be entitled for increase in contractual amount @ of Rs.430/- (3% of the minimum of pay band plus grade pay) for further extended years and no other allied benefits such as senior/selection scales etc. will be given.
- b) The service of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
- c) Contract appointee will be entitled for one day casual leave after putting one month service. This leave can be accumulated up to one year. No leave of any other kind is admissible to the contract appointee. He/She shall not be entitled for Medical Re-imbursement and LTC etc. only maternity leave to female incumbent will be given as per rules.
- d) Unauthorized absence from the duty without the approval of the controlling officer shall automatically lead to the

		<p>termination of the contract. Contract appointee shall not be entitled for contractual amount for the period of absence from duty.</p> <p>e) An official appointed on contract basis who has completed five years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.</p> <p>f) Selected candidate will have to submit a certificate of his/her fitness from a Government/ Registered Medical Practitioner. Women candidate pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidate will be re-examined for the fitness from an authorized Medical officer/ Practitioner.</p> <p>g) Contract appointee will be entitled for TA /DA if required to go on tour in connection with his/her official counterpart duty at the same rate as applicable to regular official at the minimum of pay scale.</p> <p>h) Provisions of service rules like FR,SR, Leave Rules, GPF Rules, Pension Rules & Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointees. They will be entitled for emoluments etc. as detailed in this Column.</p>
16.	Reservation:	<p>The appointment to the services shall be subject to orders regarding reservation in the service for Scheduled Castes /Scheduled Tribes /Other Backward Classes /Other categories of persons issued by the Himachal Pradesh Government from time to time.</p>

17.	Departmental Examination:	Not applicable .
18.	Power to relax:	Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order for reasons to be recorded in writing and in consultation with the Himachal Pradesh Public Service Commission relax any of the provision(s) of these rules with respect to any class or category of person(s) or post(s).
