- (e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka East African Countries of Kenya, Uganda, the United Repblic of Tanzanio (Foremerly Tanzanyika and Zanzibar), Zambia, Malwa, Zaire and Ethopia with the intention of permanently settling in India.

Provided that a candidate belonging to categories (a)(b)(c)(d) and (e) shall be a person in whose favour a certificate of eligibility has been issued by the Government of India.

A candidate whose case a certificate of eligibility is necessary may be admitted to an examination or interview conducted by the Himachal Pradesh Public Service Commission or other recruiting authority. But the offer of appointment may be given only after the necessary eligibility certificate has been issued to him by the Government of India.
