The Committee shall recommend the mode of admission, reservation, allocation of seats, fixation of fees and mode of prospectus etc. to the State Govt., in respect of all above Institutes in the State of Himachal Pradesh, is made by the aforesaid Committee except fixation of fee in favour of Abhilashi Ayurvedic Medical College & Research Institute which is affiliated to private Abhilashi University and the matter of fee comes under the domain of Education Department of H.P. State Govt.

3. The Director Ayush, H.P. and Member Secretary shall be responsible for preparing the proposal and place the same before the Prospectus Committee/admission & Fee Committee. Further the meetings for all the above mentioned Colleges will be held in April-May of every year.

4. All the Official Members of the above Committee shall not be given extra remuneration for discharging their duties as members of the Committee. However, normal TA/DA as per entitlement will be admissible.
